Portfolio Updates

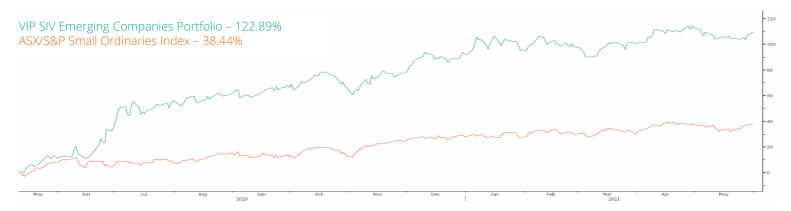

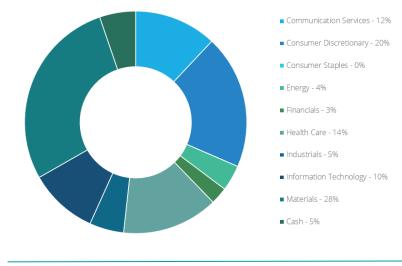
