Portfolio Updates

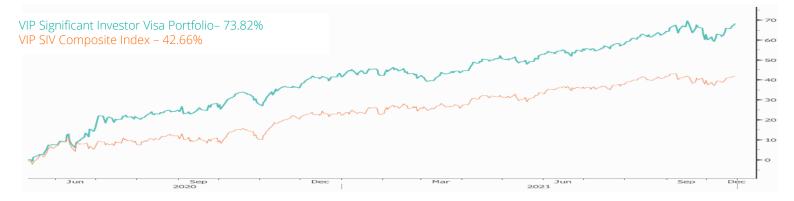
In December, the Investment Committee made the decision to add 3PL, 8CO and XF1 to the portfolio and remove SUL.

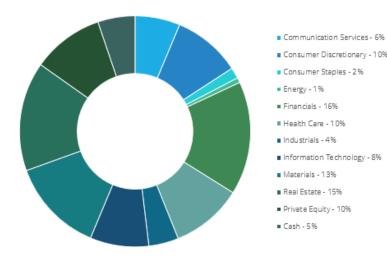
