## Portfolio Updates

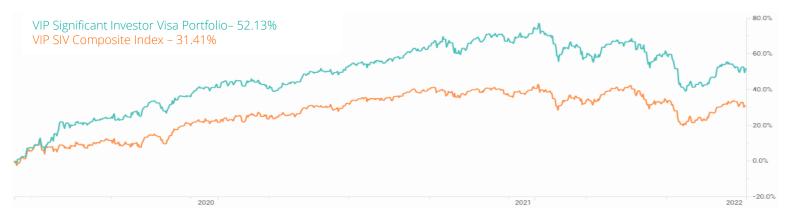

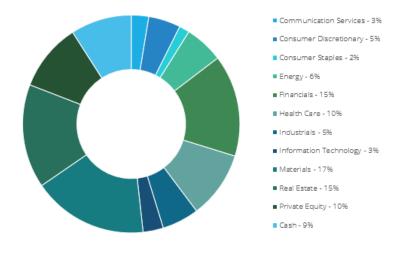
