Stock selection is guided by environmental, social, and governance screens with an emphasis on the environmental impact of the company.

Portfolio Updates

VIP's positioning through September remained defensive as we believe the combination of rising bond yields, persistent inflation, strong employment despite ongoing concerns of recession, all bode poorly for financial markets. Despite VIPs defensive allocation The SMA Climate Sustainability portfolio whilst down in absolute terms for the month outperformed its benchmark by 2% and continues to track well up 0.86% year to date and 1.88% over the last 12 months




