Since last reporting VIP's Climate sustainability portfolio is down in absolute terms as equity and bond markets faced with rising bond yields, persistent inflation, and ongoing concerns of recession, declined over the month. VIP's Climate sustainability Portfolio was down 3.9% for the month.




